
Typical Installation

Local codes shall govern installation requirements. To be installed in accordance with the manufacturers' instructions and the latest edition of the Uniform Plumbing Code. Unless otherwise specified, the assembly shall be mounted at a minimum of 12" (305mm) and a maximum of 30" (762mm) above adequate drains with sufficient side clearance for testing and maintenance. The installation shall be made so that no part of the unit can be submerged.

Specifications

The Reduced Pressure Principle Backflow Preventer shall be certified to NSF/ANSI 372, shall be ASSE® Listed 1013, approved, rated to 180°F and supplied with 90° union elbows and full port ball valves. The main body, access covers and elbows shall be low lead bronze (ASTM B 584), the seat ring and all internal polymers shall be NSF® Listed NoryI[™] and the seat disc elastomers shall be silicone. The first and second check valves shall be accessible for maintenance without removing the relief valve or the entire device from the line. If installed indoors, the installation shall be supplied with an air gap adapter, and piped to a properly sized drain. The Reduced Pressure Principle Backflow Preventer shall be a ZURN WILKINS Model 975XL2V.
